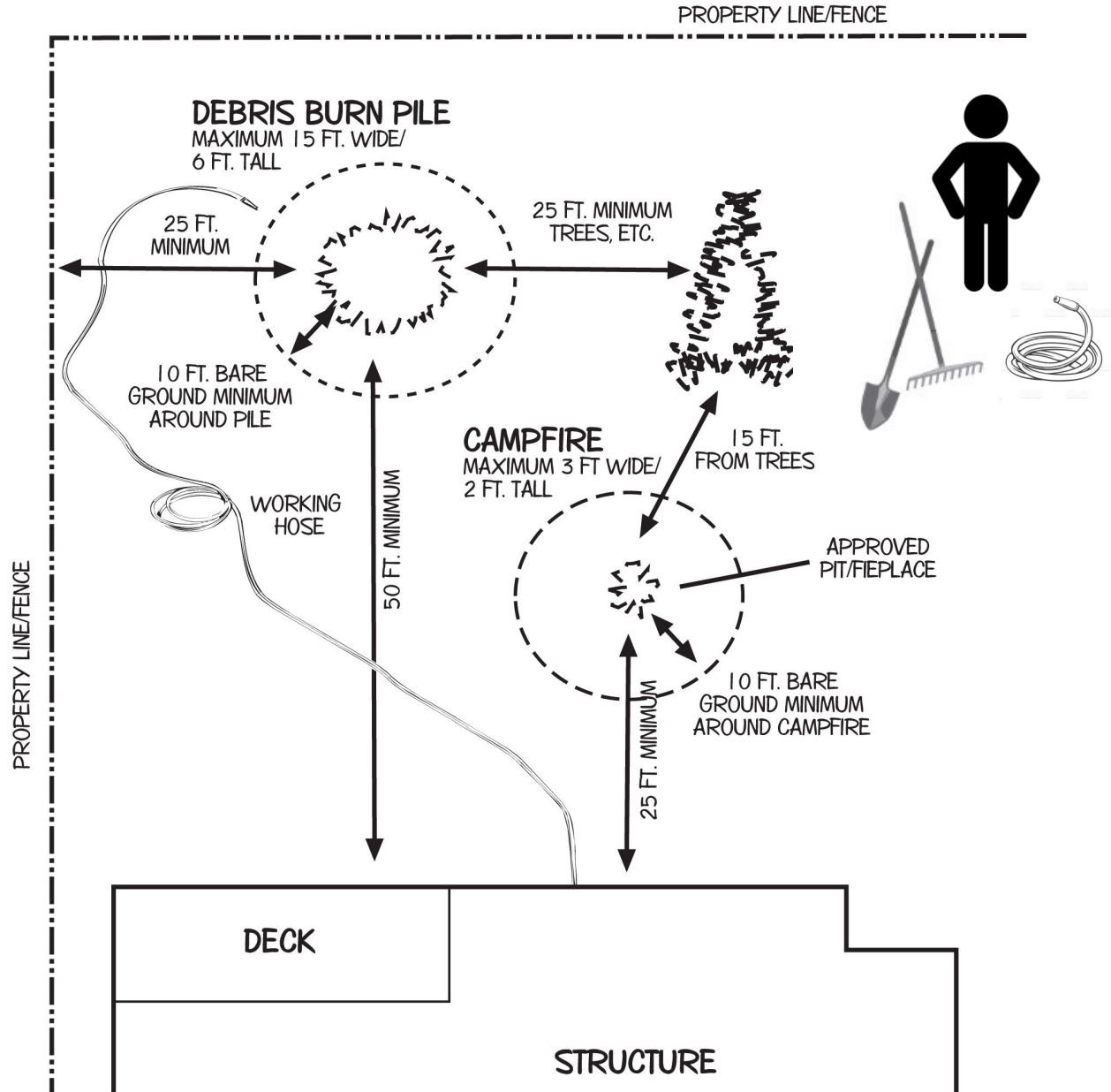

Follow the regulations · Burn safely · Be safe

IMPORTANT NOTICES

You are totally responsible and criminally and civilly liable (including suppression costs) for any fire you start. This permit does NOT relieve any responsibility for conducting a safe burn.

You are required to extinguish your fire at any time at the direction of the fire department and/if smoke is causing air quality issues (complaints).

Failure to comply with any permit requirements may result in citation and/or criminal prosecution.

If your fire gets out of control, call 911!

ALL BURNING IS PROHIBITED IF:

- Temperatures are above 90°F
- Wind speeds are predicted to be or do reach above 15 MPH.
- Fire conditions are extreme

Open debris burns are only allowed during daylight hours (must be completed or extinguished by dark). We recommend beginning your burn in the calm morning hours. If winds increase to over 15 mph, you must immediately extinguish your burn.

It is permissible to only burn:

- Dry vegetative material
- Clean wood and lumber (not painted or pressure treated)
- Dry paper and cardboard

Campfires shall only burn:

- Charcoal briquettes
- Dry cut firewood

No other materials may be burned.

BURN PERMIT

These permits are free of charge and must be filled out and kept on site during debris burns and campfires. Please read completely to ensure you are following the required regulations. Failure to do so may result in a fine. Remember, you are legally and fiscally responsible for any fire that escapes from your burn.

Open Burning is generally allowed from mid-October to mid-May, dependent on fire conditions. No open debris pile burning is allowed during fire season.

Campfires in approved rings that comply with all rules within this permit are allowed year-round unless the District is in an extreme fire condition and a total burn ban is in effect.
